No person, other than members of the Committee and the person having the floor shall be permitted to enter into any discussion. No questions shall be asked of the Committee except through the presiding officer.

Disruptive Conduct – Any person who disrupts a meeting to the extent that its orderly conduct is made impractical may be removed from the meeting by order of the presiding officer. NRS 241.030(4)(a).

Accommodations – The meeting site is accessible to individuals with disabilities. Reasonable efforts to assist and accommodate persons with physical disabilities desiring to attend shall be made per NRS 241.020(1).
