6. GENERAL BUSINESS (FOR POSSIBLE ACTION)

6.1 CONSIDERATION, DISCUSSION, AND POSSIBLE ACTION TO UPDATE LANGUAGE IN THE CITY CHARTER REGARDING MUNICIPAL COURT JURY TRIALS. (FOR POSSIBLE ACTION)

Chief Assistant City Attorney Shirle Eiting provided an overview of the language update which is predicated on a 2019 Nevada Supreme Court decision (Anderson v. Eight Judicial District Court). This decision concluded that because NRS 202.360(1)(a) prohibits a person convicted of misdemeanor domestic violence from owning a firearm, the Nevada Legislature has determined it to be a serious offense. The Court held that a jury trial is constitutionally required for such offenses, even though those offenses remain misdemeanors.

NRS 5.050 gives Sparks Municipal Court jurisdiction over misdemeanors that occur within City limits. To date, no jury trials have been held.

Committee members inquired about firearms provisions in the State and Federal laws. Mrs. Eiting provided information and explained the two laws do have different aspects.

Mrs. Eiting explained that under this new language, a defendant may request a jury trial if one is Constitutionally required according to the applicable statute(s). She also informed the Committee that if the Nevada State Legislators wished to expand or contract the language at the next legislative session, they may do so. The Charter Committee will need to find a sponsor for the Bill Draft Review (BDR) to get the language passed in 2021. The new language will be in Title IV of the Sparks Charter.

Chief Assistant City Attorney Shirle Eiting provided an overview of the language update outlining the city election process. In 2016, the Charter Committee voted to amend Charter Section 5.010, changing the general election for council seats from citywide to ward only voting. After these amendments, changes were also recommended for Section 5.020. The recommended language includes the number of candidates advancing to the General Election based on the percentage of votes received at the close of the Primary Election and will align City Charter with the Nevada Revised Statute 293C.
