PCN20-0025 – Consideration of and possible action on a request to amend a final handbook (Legends at Sparks Marina) by modifying sign standards for movie theaters for a site generally located north of I-80, south of Prater Way, and west of Sparks Boulevard, Sparks, Nevada in the NUD (New Urban District – Legends at Sparks Marina) zoning district. PCN20-0021 – Consideration of and possible action on a request to amend a tentative map (TM080001) to add 10 lots, increasing the number of lots from 183 to 193, by incorporating an approximately 2.5-acre former park site into the tentative map.
